Dan Weist - DAV

OLD BUSINESS:

Due to a lack of numbers in servicing veterans at the McCafferty VA Clinic, a service officer will no longer be stationed at that location.

A motion was made by Dan Weist and seconded by Bob Potts to approve Resolution 2015-03 providing for the purchase of one high top commercial vehicle van for the CCVSC as a mobile office to service suburbs and communities outside of city limits, expenses not to exceed \$70,000. Under discussion, it was noted that the other two commission vehicles will be used to transport veterans, outreach events and for travel for training purposes.
