A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2012-10, a resolution providing for the final payment of \$24,821.16 and closure of purchase order 1106641 with Advertising Vehicles who acquired the RTA bus contract in November 2011. A motion was made by Dan Weist and seconded by Clay Uzell to approve Resolution 2012-11, a resolution providing for the purchase of 300 Speedway Prepaid Company fuel cards, not to exceed \$15,000.00, for Veterans Service Commission clients who are in need of fuel for their vehicles. AYES: Baher, Pocci, Potts, Uzell, Weist. NAYS: None. Motion carried.

NEW BUSINESS:

Discussion took place concerning a response to Tom Meyer's February 15, 2012 WKYC televised news report on the CCVSC. At the recommendation of Judge Nancy Fuerst, the Board agreed not to respond to the report and to move forward with good advertising and positive initiatives. The Board will, however, solicit the Plain Dealer's assistance in reaching out to veterans.

On Monday, February 27, 2012 The Louis Stokes Cleveland Department of Veterans Affairs Medical Center's Parma Multi-Specialty Outpatient Clinic opened. An open house will take place on Saturday, March 10th from 10:00 a.m. to 2:00 p.m. RTA will run a bus line up and down Brook Park Road on a six-month trial basis for ridership. The Gift for Yanks program is looking into funding the installation of an audible crossing signal for blind veterans.

A motion was made by Dan Weist and seconded by Bob Potts to accept the revision to the Addendum to the Guideline for Restrictive Assistance, Assistance Requested for Child or Children Only, dated March 7, 2012.

Board outreach meetings for 2012 have been tentatively set for April 18, 2012 and September 19, 2012. Commissioner Uzell will make the necessary arrangements and provide the details at the next open public meeting.

The Board will review commission vs. county policies and will make a decision at the next meeting on areas once covered under the union contract.

The Executive Director raised the issue of drop in daycare for patrons of the VA medical center or clinic. It appears that this was never an initiative of the Veterans Service Commission.
