PURPOSE:

Bob Potts - VVA

- I attended the VVA Chapter 249 board meeting and membership meeting.
- I attended both Level III appeal hearings and both open public board meetings during the month of October.
- I stopped in to visit CCVSC staff at both the CBOC and Wade Park offices during the month.
- I did not attend the November Chapter 249 board meeting.
- Veteran's Day, November 11th, the Chapter will be the honor guard for a Veteran's Day Program at Holly Lane Elementary School at 1:00 p.m.

Dan Weist – DAV

- I attended a pre-meeting at VFW Post 7647 North Olmsted.
- I stopped in to see CCVSC staff at the Parma CBOC while there for an eye appointment.
- I attended both Level III appeal hearings and one open public board meeting during the month of October. I did not attend the October 19th outreach board meeting at 7:00 p.m., due to medical reasons
- On November 10th, three separate nursing homes have asked the post to participate in Veteran's Day ceremonies.

A motion was made by Bob Potts and seconded by Dan Weist to approve Resolution 2016-28 providing payment for the purchase of multiple domain names for a ten-year registration through Linear Creative for the completion of CCVSC re-branding (Resolution 2016012), amount not to exceed \$3,000.

A motion was made by Dan Weist and seconded by Bob Potts to approve Resolution 2017-01 requesting authority for eighteen CCVS service officers to attend training and maintain membership and accreditation with the Ohio State Association of County Veterans Service Officers (OSACVSO) and National Association of County Veterans Service Officers (NACVSO) in 2017, expenses no to exceed \$48,142.

Dan Weist made a referral to the CCVSC service department requesting an updated Income Verification Form.

EXECUTIVE SESSION:
