### **OLD BUSINESS:**

Action Items – Updates:

1) Linear Creative—No update. Work in progress.

- 2) Employee Overpayments The commission continues to receive payments from one party. Full payments are to be made by the end of next year. No update on the other party involved. The Prosecutor reached out to the other party and is waiting for a response. If no response is received by the end of the week further action will be taken.
- 3) Emergency Plan for Files No update. The Executive Director will have a quote by the next meeting.
- 4) **Dental Trial Program** No update.
- 5) Resolution 2018-13; VVA Compensation No decision has been made. The Executive Director will visit the County Executive's office for an update.
- 6) New Schedule The Director is building a report for the next meeting.
- 7) 2019 Evening Outreach Meeting –The fall outreach meeting will be determined at a future date. The Executive Director will reach out to Baldwin Wallace to inquire about meeting space in September or October.
- 8) Memorandum of Understanding The Executive Director met with Hands on Northeast Ohio. An MOU for the Stand Down is a work in progress.

## **NEW BUSINESS:**

- 1. If an internal candidate is chosen for a new position the position will be a lateral move with no pay increase for a probationary period of 180 days. Each employees' job performance will be reviewed after 90 days to provide feedback on performance and to give the employee the opportunity to reconsider the position change.
- 2. The VSC received a letter from the County Fair stating that the booth must be manned for the entire fair. Mel Baher will contact the Director of Fair Vendors to discuss the possibility of VSC coverage on the weekend only.
- 3. New hires began working on March 11, 2019.

## GOOD OF THE ORDER:

An article was published in the Plain Dealer regarding the Inspector General's demand that he have access to all county emails.

Chris Grau distributed a report he received in training. According to the report, in 2017, the number of veterans in Cuyahoga County dropped to 69,000.
