PURPOSE:

GENERAL MONTHLY MEETING

The meeting was called to order by Jon Reiss, Executive Director.

A motion was made by Chris Grau and seconded by Bob Potts to dispense with the reading of the Consent Agenda and to accept the agenda with the necessary corrections and/or additions. (All Commissioners have a copy of the minutes.) One item was set aside for discussion in Executive Session. AYES: Baher, Grau, Pocci, Potts, Uzell. NAYS: None. Motion carried.

OLD BUSINESS:

The Executive Director updated the Commissioners on fiscal outstanding expenses and the projected budget surplus. Most expense items have been cleared.

The VSC will continue with COVID protocol. Staff will work alternating weeks in the office to minimize exposure. Overtime is authorized if needed but will be kept to a minimum.

NEW BUSINESS:

A motion was made by Frank Pocci and seconded by Clay Uzell to approve Resolution 2020-30 for the Cuyahoga County Veterans Service Officers to attend training and maintain membership and accreditation. Expenses not to exceed \$63,000.

GOOD OF THE ORDER:
