AMVETS Post 80 Events

OLD BUSINESS:

Updated COVID protocols were discussed. The Executive Director will draft new protocols for review by the Board.

The October VetConnect event was discussed. As with past events, the total amount of expenses are not to exceed \$25,000.

NEW BUSINESS:

A motion was made by Bob Potts and seconded by Frank Pocci to approve Resolution 2021-06 providing for the purchase of a "dog tag" identification plate stamp machine for advertising and outreach purposes. The purchase agreement is with Identisys and will not exceed \$15,000.

A motion was made by Bob Potts and seconded by Frank Pocci to approve Resolution 2021-08 for the purchase of outreach/marketing material for outreach and support services to the veterans of Cuyahoga County. The purchase agreement is with 4imprint Business Solutions USA and will not exceed \$25,000. AYES: Grau, Pocci, Potts. NAYS: None. Motion carried.

The Deputy Director's team developed a poster based on his belief and saying, 'One Team One Fight.' The Commissioners liked the poster and welcomed the idea of posting it around the office to remind staff that we are all in the business of helping veterans together.

Staff training was discussed. The CCVSC is closed for multiple days throughout the year while the Veterans Service Officers (VSO) are in training. Due to closures during this training, staff training will not be a full day during the months when the VSO's attend training. Instead, the staff training will take place on the Tuesday immediately preceding training in Columbus. Training will be held during the morning, leaving the afternoon for travel time for the VSO's.
