PURPOSE:

GENERAL MONTHLY MEETING

The meeting was called to order by Frank Pocci, President.

#### **OLD BUSINESS:**

Construction in the VSC workspace is complete. Main office staff will return to the office next week. The parking ramp is still under construction. Staff parking will be in the lot next door until further notice.

There are no updates on the new building. A notice to proceed has not been issued as the first round of designs have not been completed. A date for lease termination for the current office space must be determined.

VetConnect 2022 will take place on September 17, 2022. There will be a wide variety of vendors to include credit unions, housing assistance, employment and homeless services.

he Executive Director briefed the Board on job duties for the Mentor Coordinator. Once staffing levels are where they are needed, the search for a Mentor Coordinator will begin.

#### **NEW BUSINESS:**

- J. Reiss provided the Board with the rough draft of his strategic plan for review. The plan will be discussed at the next open public meeting.
- J. Reiss and F. Williams presented a plan to change office hours. Staff will have days that they take walk-ins and days that they have appointments. On Fridays the offices will be closed to the public. This will enable the Veterans Service Officers to do their off-line work on Friday and focus on seeing clients during the week. It will also allow Friday's to be used for staff training and team-building. This change will curb burnout among employees. The Board has agreed to the change and the new schedule will begin on October 3, 2022.

The Executive Director distributed an advertising opportunity during the SuperBowl. The Board will discuss this at the next meeting.

A motion was made by Bob Potts and seconded by Chris Grau to approve Resolution 2022-16 for the purchase of zoo tickets to support the CCVSC VetConnect event. The agreement is agreement is with the Cleveland Metroparks Zoo for the support of VetConnect Event, not to exceed \$15,000. AYES: Baher, Grau, Pocci, Potts, Riley. NAYS: None. Motion carried.

Commissioner Baher also announced that Post 91 will be hosting a ceremony for National POW/MIA at the Post 91 pavilion. Finally, Commissioner Baher will be traveling to the national convention.
