GENERAL MONTHLY MEETING

The meeting was called to order by Frank Pocci, President.

A motion was made by Mel Baher and seconded by Chris Grau to dispense with the reading of the Consent Agenda and to accept the agenda with the necessary corrections and/or additions (All Commissioners have a copy of the minutes).

#### **OLD BUSINESS**

Changes in the Mission and Vision Statements were discussed. The Executive Director will make the suggested changes and the statements will be reviewed at an upcoming meeting.

The need for climate-controlled storage unites was discussed. Several units are needed to store flags for Memorial Day and items needed for VSC sponsored events.

#### **NEW BUSINESS:**

policy will be drafted regarding documentation for military orders. The draft will be reviewed at an upcoming meeting.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-19 to reimbursement the staff for gym memberships at gyms/fitness centers, not to exceed \$65 per month, per employee, not to exceed and agency total of \$25,000.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-20 for the purchase agreement with Enterprise Resource Partners for the eVetAssist veteran software program for the 2023 fiscal year for Cuyahoga County Veterans Service Commission, not to exceed \$7,000.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-21 adjusting employee mileage and per diem travel reimbursement rates in accordance with standard federal rates for year 2023.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-22 requesting authority for five Cuyahoga County Veterans Service Commissioners, Executive Director, and Deputy Director to attend various conferences and training to maintain accreditation with the Ohio Association of Veterans Service Commissioners (OSAVSC) in 2023, expenses not to exceed \$10,000.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-23 requesting authority for twenty-two Cuyahoga County Veterans Service Officers and Commissioners to attend training and maintain membership and accreditation with the Ohio State Association of County Veterans Service Officer (OSACVSO) and National Association of County Veterans Service Officer (NACVSO) in 2023, not to exceed 108,477.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-24 providing for the purchase of an advertising agreement with DD214 Chronicle for the Cuyahoga County Veterans Service Commission for one (1) year of advertising, not to exceed \$8,000.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-29 for the renewal of services with Feedback Now, a feedback system for the clients of the Cuyahoga County Veterans Service ommission to provide real-time customer feedback in and effort to improve customer service, not to exceed \$5,500.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-30 requesting authority for the Executive and Deputy Director to attend conferences and training seminars as necessary to enhance veteran services throughout Cuyahoga County for the years 2022-2023, expenses not to exceed \$20,000.

A motion was made by Mel Baher and seconded by Bob Potts to approve Resolution 2022-31 providing for the rental agreement with U-Haul Self-Storage of Parma for storage units need for excess items, not to exceed \$10,835.20.
