#### **COMMISSIONERS REPORTS**

Mel Baher - American Legion

- February 8, 2024 attended the Post 91 membership meeting held at 7:00 p.m.

- February 22, 2024 attended the Post 91 Executive Board meeting held at 7:00 p.m.
  - presented updated financial reports as Post Finance Officer
- February 25, 2024 left for Washington, DC to attend the American Legion National Legislative conference held at the Washington Hilton on Monday, February 26 and Tuesday, February 27, 2024. The American Legion Legislative Agenda for the 118<sup>th</sup> Congress is:
  - 1. Suicide Prevention and Mental Health for Active Duty and all veterans.

- 2. Alternative Treatments for Veterans experiencing drug or alcohol disorder.
- 3. VA Health Care Modernization implement electronic health records.
- 4. PACT Act Implementation and oversight claim wait is as much as 157 days.
- 5. Safeguard Veterans Benefits Stop persons or companies charging veterans to file and prepare claims WITHOUT VA accreditation.
- 6. Concurrent Receipt STOP VA compensation being deducted from DOD retirement pay for veterans with service-connected disabilities less than 50%.
- 7. Guard and Reserve GI Bill Parity When federally activated they should NOT be deprived of education benefits as earned by current active-duty members.
- 8. GI Bill for Honorable Service make "general under honorable conditions" equal for VA education assistance benefits the same as "Honorable."
- 9. Military Quality of Life provide proper compensation, appropriate housing, quality healthcare, reasonably priced commissaries, and childcare services.
- 10. Pay the Coast Guard guarantee pay to personnel during ANY shutdown.
- 11. Access to healthcare for overseas military and families in remote locations.
- 12. Improving the Transition Assistance Program (TAP).
- 13. Protect our American Flag pass the Flag Code Modernization Act of 2021.

#### **OLD BUSINESS**

There are no updates on the Veterans Service Commission's current space. The final documents for the new headquarters are in review. Once reviews are completed, the plans will go out for bid. It is time to upgrade computer equipment. Computers will be replaced once the VSC relocates to the new building.

There are no updates for mobile vehicle use or the Parma CBOC. The transportation report and recommendation to the board is a work in progress. The VSC is waiting for quotes for active shooter and team building/diversity training.

#### **NEW BUSINESS:**

The 2025 Budget was discussed. Budget items discussed include assistance to Cleveland State, an in-house tuition assistance program and a new vehicle for the VSC.

On March 5, 2024, the VA expanded healthcare to include increased eligibility for VA healthcare by the PACT Act. Executive Director Reiss was asked to find out more about who this will impact and what group they will be in at the VA.

The VSC received a request for tuition assistance for Cleveland State veterans. The VSC is unable to assist in this way, but Cleveland State will be made aware of the tuition assistance program once details are determined.

After discussion, the Board made the decision to close the office on April 8<sup>th</sup> for the solar eclipse due to expected increased traffic and visitors to the city.

### GOOD OF THE ORDER:

Deputy Director Williams expressed concern regarding client complaints of prejudiced treatment by two staff members. Mr. Williams will have a discussion with both employees.

Commissioner Riley complimented C. Reese and J. Rosine for their service to veterans.

### **EXECUTIVE SESSION:**

A motion was made by Frank Pocci to go into Executive Session to consider employment of a public employee and a client case and appeal. Motion seconded by Bob Potts.
